



MEMORANDUM OF UNDERSTANDING FOR ACADEMIC COLLABORATION

AND

GOVT. COLLEGE BHATTU KALAN, ESTD. 1987

This agreement is made on this 2nd August 2021, between **Manohar Memorial College, Fatehabad** herein after referred to as “MMC” which expression shall, unless exclude by or repugnant to the context, be deemed to include its successors in office and assignees of the first part and **Govt. College Bhattu Kalan** hereinafter referred to as “GCBK” which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its/his/her/their respective executors, administrators and successors for the time being of the said College as the case may be on the second part.

WHEREAS the Manohar Memorial College, Fatehabad established in the year 1970, affiliated to Chaudhary Devi Lal University, Sirsa situated at Ratia Road, Fatehabad has been marching ahead on its uphill journey since its inception. It has since become synonymous with dedication, commitment and service to the community in this educationally and culturally backward region. It is universally recognised for its impeccable credentials of being a top-ranking and first-rate institution all over the state. It has left behind more than four glorious decades of its eventful history.

And WHEREAS the Govt. College, Bhattu Kalan established in the year 1987, affiliated to Chaudhary Devi Lal University, Sirsa, being a Co-Education college, it caters to the needs of the girls from rural area perfectly. Starting with the minimum requirements, the college has progressed by leaps and bounds and has undergone a complete transformation. The college has lush green lawn, big ground, Air Conditioned library, Smart Class Room, well equipped Science Labs, Computer Labs and spacious classrooms. Here, our emphasis is on the all round development of the students personality so that they can meet the challenges of life with confidence.

Whereas both the parties has shown their desire to enter into this agreement (MOU) that it could prove to be mutually beneficial to both the parties that allows for panoramic sharing of resource beyond the physical boundaries of College boundaries.

1. Objectives of MOU

The objectives of MOU are:

- a) To promote and enhance academic interest between GCBK and MMC.
- b) To create means of cooperative efforts between the two institutes to effect academic collaboration through joint organization of Faculty development Programs, Workshops, Training Sessions and other academic activities for both students and teachers.
- c) To promote research work of teachers on aided or budgeted posts that can supervise/co-supervise joint research studies.
- d) Upgrading faculty with new teaching tools.
- e) Sharing techniques and expertise for improving the quality of Education.
- f) To share the e-library facilities at the institutions.

2. Technical areas of collaborations

- a) Provide academic interaction by delivering special lectures on topics of relevance to the inter-disciplinary research and literary studies at both institutes.
- b) Usage of research and academic infrastructure for students, staff and faculty members of both institutes.

3. Proposed mode of collaborations

GCBK and MMC propose to collaborate through the following:

- a) Cooperation and promotion of research, education and training in areas of mutual interest.
- b) Any other appropriate mode of interaction agreed upon between GCBK and MMC. A specific plan will be worked out by the institutes depending upon availability of resources.

4. Terms and conditions

- a) The cost of development of infrastructure should be borne by the first party i.e.MMC.
- b) For education and research, the financial arrangements will be made on the basis of mutually agreed terms of both institutes.
- c) Usage of academic infrastructure of GCBK and MMC can be allowed for limited period subject to its availability.
- d) Both institutes agree to help, identify and invite the faculty members and researchers from the other institutes to participate in conferences, workshops and short-term courses.

Duration of MOU:

The duration of this MOU shall be for a period of three years from the effective date.

Confidentiality:

Each party agrees that it shall not, at any time, during or after executing the activities of this MOU, disclose any information in relation to these activities or the affairs of mentorship program without the express consent of both parties. Any sensitive topics that are discussed will be held in the highest confidence.

Entirety of Understanding

This MOU contains the final and entire understanding between the parties, and all future projects or agreements shall be in a separate writing based upon mutual agreement of the parties, and neither the parties nor their agents shall be bound by any terms, conditions, statements, warranties, or representations, either oral or written, not herein contained.

Governing Law: This MOU and all issues arising out of the same shall be construed in accordance with the laws of India.

Arbitration

Any dispute arising with regard to any aspect of this MOU shall be settled through mutual consultations and agreements by the parties to the MOU.

Commitments of First and Second Party

We have read the above and undertake that we will conduct our participation in this mentorship in accordance with the Mentoring MOU and principles and description provided above.
