1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Established by the Government of Haryana in 1987, Government College Bhattu Kalan has emerged over the years as a leading co-educational institute to offer degrees up to graduation level in Arts Commerce and science faculties. Situated at a distance of about 20 Km from the district headquarters, Fatehabad and about 30 Km from the famous historical site- Agroha, which is the birth place of Aggarwal community in the country, the college has adequate rail-road connectivity with Hisar (55 KM), Sirsa (50 Km), Delhi (200 Km) and the state capital, Chandigarh (240 Km). It was previously affiliated to Kurukshetra University, Kurukshetra, but now it has its permanent affiliation with Ch. Devi Lal University, Sirsa (we.f 2011-12 session), due to a decision of the Government to affiliate all Government, private and self financed colleges lying in Fatehabad and Sirsa districts with the latter. The college gets 100% grants from the Government of Haryana and from Nov. 2014 it is affiliated with UGC u/s 2f and 12b of the UGC Act) However we did not receive any grant from UGC till date. The first NAAC accreditation of the college had taken place in 2003 and it was then awarded C+ grade and in second cycle in 2016 this institution received B grade. However, much has changed since then- infrastructure wise as well as teaching-learning process wise.

The college, with around 1000 students from lower middle class backgrounds, aims to provide personal growth, knowledge, exposure, and career direction, with dedicated staff and a beautiful campus.

The college has well-furnished classrooms, laboratories for various departments, smart class rooms, AC-fitted computer labs, EDUSAT room, and an air-conditioned library. It is situated on 14 acres of scenic countryside, with a large play ground, 400 M track, and various outdoor sports facilities. Indoor games and gym equipment are also available. The college has a canteen, vehicle parking area, toilet blocks, interlocking pavements, lush green lawns, and a separate girls' common room. The college hosts various activities, including academic, cultural, sports, NCC, NSS, Women Cell, Placement Cell, Legal Literacy Cell, Youth Red Cross, and Eco Club, and offers fee concessions and scholarships to needy students.

- Lack of clarity about aims & objectives.
- Lack of non government financial resources.
- Lack of incentives for industrious teachers & other staff members.
- Poor academic background of the rural students from school days

- Communication skills, particularly in English, is a challenge due to the rural background of students.
- Collaboration with external agencies is a challenge.
- The deputation of the staff in administrative and non-academic activities like election duties, pandemic duties, making of voter IDs, driving licences, and passports, etc. is a hurdle and it hampers the teaching-learning routine.
- The chances of campus placements are few as the college does not have direct contact with the MNCs owing to the lack of proper mechanism.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Government College Bhattu Kalan, a constituent college of Chaudhary Devi Lal University Sirsa, follows a predetermined syllabus determined by the affiliating university C.D.L.U., Sirsa through discussions with subject experts. The college has a well-defined curriculum delivery mechanism, with weekly lesson plans ensuring optimum spacing of the syllabus. Academic processes are streamlined, with timetables, workloads, and administrative tasks prepared well in advance of teaching sessions. Teachers discuss syllabus concepts with students, encouraging them to ask questions and provide feedback.

The college integrates ICT, audio-videos, smart classrooms, language labs, and compulsory computer awareness classes in the curriculum delivery process. Students are given opportunities to prepare and speak on syllabus topics through seminars, oral presentations, group discussions, and active class participation. The college has a well-equipped library with nearly 18,000 books.

Teachers regularly update their disciplinary knowledge through active involvement in orientation courses, refresher courses, faculty development programs, seminars, conferences, professional development/administrative training programs, and participation in decision-making bodies of the University. By utilizing updated knowledge, students can clear competitive exams like NTA-UGC NET.

The Environment subject is taught in all six semesters of BA, B.Com, and BSc courses, exploring the relationship between humans and the environment.

During the COVID-19 pandemic, faculty members used ICT-assisted methods like online lectures, Google Classroom, Zoom App, WhatsApp, PowerPoint presentations, YouTube lectures, and EPG Pathshala to restore

faith in the teaching learning process. The institution receives feedback from stakeholders and provides action-oriented reports on its academic performance and ambience.

The IQAC and college council encourage self-assessment to critically reflect on practices, supporting the amalgamation of stakeholders' interests and the institution.

Teaching-learning and Evaluation

Right from admission, the college follows a well-administered and transparent procedure with ease of availability of information on our website and on college notice board. Merit list are displayed on college website for ease of students.

Average enrolment percentage of the last five years i.e. 2018-2019 to-2022-2023 is 87.31. During the admission, seats are always filled by strictly following the guidelines of the state reservation policy. Average percentage of seats filled against reserved categories is 84.12

Student-teacher ratio in the latest completed academic year was 50.75. Average percentage of full-time teachers against sanctioned posts during the last five years is 81.95. Percentage of full time teachers with NET/SET/SLET/ Ph. D./D.Sc. / D.Litt./L.L.D. during the last five years was 100%.

Teaching/Lesson plans focus on predefined activities, and scholarships are provided to socially or economically disadvantaged students. The institution fosters an integrated learning environment through seminars, debates, case studies, quizzes, departmental activities, awareness rallies, cleanliness campaigns, and Eco clubs.

The institution uses various teaching methods, ICT-enabled teaching, experiential learning, seminars, and black-board presentations to enhance students' learning experience. ICT tools, such as projectors, printers, and smart whiteboards, are used for online classes and guest lectures.

The institution also provides support to slow learners by arranging assistance, providing tutorial assignments, and encouraging participation in activities to develop social skills.

Internal assessment marks are based on two assignments, one class test, and attendance of students. The college follows strict guidelines and rules issued by the affiliating university while conducting internal and semester-end examinations.

A grievance redressal committee is constituted at the institute level to handle issues related to the evaluation process. The university offers a challenge evaluation process for students who are dissatisfied with re-counting/re-evaluation results. The process is conducted by subject experts and is transparent and time-bound.

The institution has issued Programme and course outcomes to teachers and students in advance, ensuring alignment with the institution's mission and vision. These outcomes provide clarity on students' expected knowledge, skills, and attitudes, helping teachers design course content and assessment criteria. The institution prioritizes stakeholders by communicating the intended outcomes through an evaluation system and student feedback.

Research, Innovations and Extension

The college encourages all faculties to conduct research and has established a digital resource center with computer systems, printers, scanners, and photocopier machines. 21 research papers of the faculty members have got published in various national and international journals. **11 books and chapters in edited volumes/books published and papers published in national/ international conference proceedings per teacher during last five years.**

It also encourages active participation in presentation contests and collaborations with education institutes. The institute encourages faculty participation in conferences, workshops, seminars, and field visits to advance research culture. Almost every faculty member participated in conferences, workshops, seminars during the last five years.

The mentorship program supports students through 360-degree analyses of academic performance and developmental activities.

The college focuses on instilling moral values, compassionate conduct, and social responsibility in students.

Extension activities are run in the neighborhood community to develop social responsibility, leadership qualities, and awareness of legal matters. These activities aim to spread awareness, develop personality, and promote functional literacy among the masses.

146 Extension and outreach programs conducted by the institution through organized forums including NSS/NCC with involvement of community during the last five years.

Students participating in these activities complement their academic learning and develop team spirit and fellow feeling. The cultural committee organizes cultural events like Talent Hunt Competition and sur utsav, and the annual function of the college.

Sports meet is also organized in college annually. Sports teams of college participate in intra-college and inter college events. Students are made aware about their voting rights by activities of Voter ID Committee.

The college has made significant contributions to society through blood drives and vaccination campaigns, and its staff and students have contributed to society for the past five academic years.

Two functional MoUs/linkages with institutions/ industries in India have been achieved during the last five years.

Infrastructure and Learning Resources

The institution has a comprehensive infrastructure and facilities, including 16 classrooms, one seminar hall, and 10 ICT-enabled classrooms. These classrooms are occupied throughout the daily study hours, with a spread timetable to ensure maximum utilization. The college also has four laboratories for various subjects, including physics, chemistry, geography, and defense studies.

The college organizes cultural committees for smooth functioning of cultural activities, such as Talent Search Programmes and Sur-Utsav Programmes. It also has a large sports facility with a badminton court and volleyball court for sports students. The college grounds are used for various events, including convocation ceremonies and inter-college sports functions.

The library plays a vital role in enhancing the academic and research environment in education institutions. It houses vast collections of academic books, journals, magazines, reference books, and newspapers, which are made available to students to increase their knowledge and understanding on various subjects. The library is fully automated using the Integrated Library Management System (ILMS) software SOUL 3.0, which allows for book entries, book issues, returns, and stock checking.

The institution has an active membership of the British Library and National Digital Library, providing various services to students and staff members. The library is fully air-conditioned.

During the COVID-19 pandemic, the college purchased ICT equipment to aid teachers in conducting online classes and creating e-content such as videos, presentations, images, and quizzes. New smart classrooms were added, and the institution has 100 MBPS bandwidth facility, including Wi-Fi coverage on campus. Student – Computer ratio for latest completed academic year is 15.86

ICT tools used by the institution include projectors, desktops and laptops, printers, photocopier machines, scanners, seminar rooms, interactive smart white boards, online classes through Google Meet and Google Classroom, and faculty use of PowerPoint presentations, Industry Connect, online quizzes, videoconferencing, video lectures, online competitions, and workshops.

The college offers facilities for disabled individuals, educational programs, and a variety of clubs, while also providing awareness about environmental, social, and health issues, tours, and various departments for various subjects.

Student Support and Progression

64.13 percent of students benefited from government scholarships and freeships over the previous five years. Colleges ran programs and activities to improve life skills (yoga, physical fitness, health and hygiene, self-employment, and entrepreneurial skills), language and communication skills, and soft skills over the previous five years. 44.86 percent of students benefited from career counseling and guidance for competitive exams provided by the institution. The institution has a redressal mechanism for student grievances, including cases of sexual harassment and ragging. This organization implements zero tolerance policies and raises awareness of them throughout the organization. Students have the option to file their complaints online or offline. Through the proper committees, the college guarantees the prompt resolution of grievances. Fourty Seven students have qualified for state or national level eligibility tests.

The college, despite lacking an official Alumni Association, organizes alumni gatherings to connect and gather feedback. These meetings allow former students to share experiences and suggestions for improving the college's environment. The college also benefits from alumni' generosity, as they donate items for the institution's growth and contribute to a healthy learning environment. The college recognizes the importance of fostering a strong alumni network, ensuring their voices are heard and their contributions acknowledged.

The institution has various co-curricular, cultural and sports activities to ensure the holistic development of the students. Students actively participate in extension activities through NCC, NSS, YRC etc. 338 sports and cultural events have been held at Government College bhattu Kalan over the last five years.

Governance, Leadership and Management

The college's governance aligns with its vision and mission, aiming to transform youth into competent and socially responsible citizens through education. This is achieved through degree courses, co-curricular activities, cultural programs, and social outreach programs.

It operates through decentralization and participative management, with the Principal as the first among equals. The college functions with faculty, staff, and students.

The college follows guidelines from the Directorate General of Higher Education and Chaudhary Devi Lal University, Sirsa, focusing on teaching strategies, transparency, and active faculty participation, using ICT tools and online admission processes. The college has service rules, recruitment rules, and promotional policies. Faculty members participate in seminars and research, and their work is published in reputable journals.

Institution implements e-governance in its operations in Administration Finance, Accounts, Examination, Student Admission and Support.

The institution offers welfare schemes for teaching and non-teaching staff, as well as students, in line with government norms. Teaching staff receive GPF Advance Loans, while non-teaching staff receive Festival Loans and Wheat Loans.

The institution grants duty leave to teachers for workshops, seminars, conferences, orientation programs, refresher courses, and over 250 professional development programs have been attended by faculty over the past five years.

The institution ensures timely fund collection and utilization, scrutinizing purchases by committees, and maintaining transparency through internal checks and controls, with external audits conducted by the Govt. of Haryana.

The IQAC at a college is instrumental in implementing quality assurance strategies and processes. Its vision is to educate students to become professional and socially responsible citizens. During the COVID-19 pandemic, the IQAC and NSS/NCC organized blood donation camps, vaccination camps and conducted online co-curricular activities. It also conducted social outreach programs to instill moral values. The IQAC has focused on mental health and social responsibility programs, addressing multicultural backgrounds and diversity. It also introduced gender sensitization programs to empower women. Regular meetings with stakeholders help identify areas for improvement. The IQAC's recent tasks include online education and COVID-19 awareness.

Institutional Values and Best Practices

The NSS Girls UNIT, Women Cell, and Anti-Sexual Harassment Committee at the college promote gender

equity and sensitization through posters, a complaint box, mobile numbers, CCTV cameras, and self-defense workshops. They also maintain strict confidentiality and have Grievance Redressal mechanisms, Anti-Ragging Committee, and Parent Teacher meetings for student safety. The college offers separate common rooms for girls, extension lectures on gender sensitization, and workshops on gender discrimination awareness and women's security.

The college educates students on balancing livelihood and life, promotes environmental awareness, and offers mandatory courses like Constitution of India. Students are educated on their rights, duties, and responsibilities as Indian citizens during their induction and other programs.

The college conducts awareness programs on issues like plastic ban, cleanliness, and Swachh Bharat. It has policies and a code of conduct reflecting its core values. The college celebrates Constitution Day, Republic Day, and Independence Day annually, encouraging students to participate in related activities. The college organizes blood donation camps, road safety rallies, and cleaning and plantation activities.

The Best Practice 01 title focuses on the implementation of Identity Cards in colleges to maintain discipline, prevent outsiders, and bring uniformity in students. It is the moral duty of every student to wear an I-card, which inculcates discipline and prevents unwanted elements from entering the college premises. The college is continuously adopting this practice, issuing new I-cards every year, and conducting library transactions through I-cards.

The Best Practice 02 title aims to build trust between local communities and college staff and students, provide knowledge of local issues, remove barriers, boost mutual understanding, and develop cooperation between the college and community. This practice started under the guidance of the Principal and College Council, and has developed healthy relationships between the community and college.

The results of the practice include eradicating ragging, providing students with information about rules, regulations, policies, and committees, and donating water coolers, installing water purifiers, sheds, and books to help needy and poor students. The college faces challenges in convincing the people of the adjoining area to establish mutual understanding, but it has gradually gained support and participation in various activities.

The college has a well defined mechanism for curriculum delivery and documentation. The curriculum scheme is decided by the affiliating university C.D.L.U., Sirsa through comprehensive discussion with subject experts in the meetings of the Board of Studies. The curriculum delivery is planned before the commencement of regular studies through weekly lesson plans ensuring optimum spacing of syllabus in study days. The lesson plans are so devised that an exhaustive coverage of syllabus can be ensured. The teachers discuss with students the concepts related to syllabus units and provide them the relevant current information. The students are encouraged to ask questions and provide their inputs to the teachers for effective delivery of curriculum subject matters. The teachers also ask questions from them to get immediate and effective feedback of what they are teaching. The optimum use of ICT through audio-videos, smart class rooms, language labs, compulsory computer awareness classes has been well integrated in the process of curriculum delivery. Not only this, students have been given opportunities to prepare and speak on the topics which are in their syllabus through seminars, oral presentation of assignments, group discussions and active class participation. Students are also encouraged to refer to the standard prescribed texts written by the renowned scholars of the respective subjects. They are also provided the written handouts and other study material for ready reference. In the practical subjects, they have been given thorough grounding in the prescribed syllabus units. The concerned teachers also ensure that the students develop in themselves a scientific temper and an acumen to understand the concepts by doing practical's. The teachers plan assignments and class tests in such a manner which not only provides comprehensive coverage of syllabus but is also helpful to students in their semester exams. The college has undoubtedly a mechanism for the well planned curriculum delivery. Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

The faculty members at the institution use various teaching methods such as lectures, interactive sessions, computer-assisted methods, and experiment methods to enhance the learning experience of students. They use Power Point presentations, You-Tube lectures and computer-based materials. The teaching-learning process is made more effective through the use of ICT enabled teaching, experiential learning, student seminars, summer internship programs, group learning methods, and black-board presentations. 2.5 Evaluation Process and Reforms

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Assignments:

Assignments questions are discussed with students. The students submit two assignments based on their syllabus. Both assignments carry 5 marks each.

Class test: one class test is conducted by each teacher. There are 5 marks assigned for class test as per rules.

Internal Assessment Marks:

Internal Assessment Marks are based on two assignments, one class test and attendance of students comprises twenty marks.

Assignments and sessional exam marks are conveyed to students.

Practical Examination:

Evaluation is done by one external and one internal examiner with transparency based on different parameters decided by both examiners.

Seminar and Viva-Voce exam: This exam is held by department of commerce in even semester. Evaluation is done by one external and one internal examiner with transparency based on different parameters as per syllabus.

The institute has devised an efficient mechanism to deal with examination related grievances which transparent in the pattern and conduction of CIE and rectification of grievances is time bound. The college follows strictly the guidelines and rules issued by the affiliating university while conducting internals and semester- end examinations.

At Institute level

At Institute level, grievance redressal committee, comprising of a senior teacher as convener and other teaching staff as members, is constituted to handle the issues regarding evaluation process. The teacher distributes evaluated answer scripts to students, and any clarifications or grievances are addressed by the teacher. The internal marks are displayed on the notice board. If any discrepancy like mistakes in question paper, mark allocation, correction is noticed by the students, the concerned teacher will resolve the discrepancy, and the necessary corrections will be made. If a student is not satisfied with the marks awarded even after resolved by the teacher, then he may represent the same to the HOD concerned. All such representations are taken positively and are reassessed by another teacher if necessary.

Students are counseled by the faculty mentor, and tutorial classes are conducted for students who have failed in the examinations.

Retest for the Internal Assessment are conducted for Students who remain absent for internal exams due to genuine reason. Within a time bound the Internal Assessment marks are entered in the University web portal.

At University level

If students have grievances related to evaluation of university answer scripts it is intimated to the subject handling faculty and head of the department if necessary, for further action. Students can bring their grievances by applying for the following evaluation procedure:

Re-Evaluation

Students can apply for re-evaluation of their answer scripts within a week from the declaration of results if they are not satisfied with their results. The results of re-evaluation will be announced as per the university norms.

Challenge Evaluation

If the re-counting/re-evaluation results are not satisfactory, a student can apply for challenge evaluation within a week after the announcement of the revaluation results. The evaluation process is carried out by subject experts. Result will be announced before commencement of University Examination. So maximum chances are given to the students to clear the subject. The entire process is maintained transparent and time bound by the university.

There are 16 class rooms including one seminar hall used for teaching purpose. Out of these 16 classrooms 10 classrooms are ICT- enabled facilities such as smart class, projector, wifi, LAN etc..The classrooms are occupied throughout the daily study hours and the timetable is so spread that the maximum utilization of them is ensured. Classrooms have had one setup: straight rows of desks facing the front of the classroom. The row style allows teachers ample amount of space to walk around. This makes it easier for teachers to supervise the students and insuring that students stay focused.

Computers lab

There are two computer labs in this college. The computers facilities are used by all the enrolled students in the practical groups of students. The college assesses time to time the need of maintenance and up gradation of ICT tools such as internet facility.

Laboratories

There are four Laboratories in this college viz., physics, chemistry, geography and defense studies. These Laboratories are used by all the enrolled students in respective subjects for practical purpose. Each group of practical subject consists of 15 to 25 students.

Cultural activities:

The college constitutes a cultural committee every year for smooth functioning of cultural activities throughout the year. The committees functions independently for their allotted work under the overall supervision of Principal. The college organizes one Talent Search Programme for newly admitted students in odd semester each year. The college hosts a Sur-Utsav Programme in even semester. The college has an adequate facility for organizing these activities including a seminar hall, main stage for organizing literary events and one big stage for singing and dancing events.

Sports, games (indoor, outdoor)

The college has an adequate facility for organizing sports events. It has one big play ground for cricket, football, kabaddi, kho-kho, athletic and such events. There is one badminton court in the campus and one volley-boll court for assisting sports students. The sports facilities are made available to students and the expert advice of the faculty members of the Dept. of Physical education is always with them. The college has 16 classrooms, including one seminar hall, with ten of them equipped with smart classes, projectors, Wi-Fi, and LAN. The college conducts live budget telecasts to help students gain practical knowledge. The institution periodically assesses the need for maintenance and upgrades of ICT tools, such as internet facilities, smart classrooms, printers, and computers, and strives to provide high-speed internet and Wi-Fi for teachers and students. Now the institution has **100 MBPS bandwidth facility including Wi-Fi coverage in campus.**

Industry interactions and collaborations are established through job fairs, workshops, and training programs under various cells, including Placement Cells.

The institution has an effective and efficient administrative setup, with the Principal being the final authority in financial matters and day-to-day running of the college. Various bodies like the Teachers' Council, Students' Council, and Committees are set up with teacher Convenors as heads to facilitate research-oriented activities, advise on library policies, and organize cultural events, placement drives, and medical emergencies.
