About the College

Established by the Government of Haryana in 1987, Government College Bhattu Kalan has emerged over the years as a leading co-educational institute to offer degrees up to graduation level in Arts, Commerce and Science faculties. Situated at a distance of about 20 Km from the district headquarters, Fatehabad and about 30 Km from the famous historical site- Agroha, which is the birth place of Aggarwal community in the country, the college has adequate rail-road connectivity with Hisar (55 KM), Sirsa (50 Km), Delhi (200 Km) and the state capital, Chandigarh (240 Km). It was previously affiliated to Kurukshetra University, Kurukshetra, but now it has its permanent affiliation with Ch. Devi Lal University, Sirsa (w.e.f 2011-12 session), due to a decision of the Government to affiliate all Government, private and self financed colleges lying in Fatehabad and Sirsa districts with the latter. The college gets 100% grants from the Government of Haryana and from Nov. 2014, it is affiliated with UGC u/s 2f and 12b of the UGC Act). The Last NAAC accreditation of the college took place in 2016 and received B grade. However, much has changed since then infrastructure wise as well as teaching-learning process wise.

About the Seminar
